1. To utilize NeFT payment option, you need to transfer funds to any of the designated MCA21 accounts, via internet banking facility offered by the bank in which you hold an account. The following are the MCA designated bank accounts:HDFC Bank- 04990920001637 Punjab National Bank- 1120002102318748
2. Please specify SRN in the remarks or payment remarks column while transferring fund through NEFT (internet banking facility of your bank).
3. NEFT is available within a time-window (9 am - 7 pm on weekdays; 9 am - 1 pm on Saturdays and not available on public holidays and Sundays).
4. Please don't pay a consolidated amount for multiple SRNs. You will not be able to link any of the SRNs.
5. Please ensure to transfer full amount in one single transaction for a particular SRN. Amount can't be divided into multiple payments.
6. NEFT service charges, if any, will be borne by the user.
7. Upon successful funds transfer, your bank will provide a unique transaction number (UTN) for the NEFT transfer.
8. Via approved RBI transfer mode, the payment amount will be received by the MCA designated banks
9. MCA designated banks will send details of these transactions to MCA21 system.
10. Once the details are updated in the MCA21 system, you shall be required to link the payment details with the SRN on the MCA21 portal (under the Services tab after login on MCA21 portal)

The following details shall be required at the time of linking the payment details with the SRN- SRN, Amount of SRN, UTN and the bank account number from which payment was made.

Please note that the payment details shall be sent from the designated banks and updated in the MCA21 system within 6 hrs 24 hrs from the time of payment. Therefore, you are required to link the SRN after the aforesaid time period.

Linking shall be allowed only within 2 days of the reporting of payment by the bank. Once this time period is over, no linking will be allowed and the corresponding service request shall not be accepted. In case the linking is not done within the 2 day period, payment shall be reversed by the concerned bank.
