The short-term rating has also been revised from [ICRA]A1+ (pronounced ICRA A one plus) to [ICRA]A2+ (pronounced ICRA A two plus). The ratings have been removed from "rating watch with developing implication". The Outlook on the long-term rating is Negative.

The aforesaid ratings will be due for surveillance anytime before July 31, 2019.

Rationale

The revision in the ratings factors in the continued deterioration in the profitability, owing to lower than expected increase in realisation not adequately compensating for the significant increase in labour expenses in the current financial year, which along with debt funded high exposure to group companies, have kept the capital structure stretched and debt coverage indicators under pressure. The liquidity position of the company also witnessed considerable deterioration. Although the company used the proceeds from the sale of the first tranche of gardens (almost Rs 470 crore) to reduce debt, however, contrary to ICRA's expectation, total debt outstanding still remains high on account of increased exposure to group companies. While revising the ratings, ICRA has taken note of the expected receipt of the balance proceeds from the sale of 2nd trance of gardens with which the management plans to reduce debt, which would also support the liquidity of the company. Although ICRA notes that the company has plans to reduce its debt over the short term, continued exposure to group companies, albeit reduced, would keep MRIL's borrowings elevated at least over the short term. In addition, input costs pressures is expected to keep the operating profitability (OPM) of the company under pressure, notwithstanding the cost control exercises undertaken. During CY2018, the performance of the overseas operations was also adversely impacted owing to subdued tea prices in the African market. In the current year too, prices at Kenyan auctions have remained largely tepid. Going forward, the trend in tea prices, relative to costs, timeliness of the inflow of proceeds from the 2nd tranche of garden sale and timely fruition of further deleveraging plans of the company would be the critical factors determining the overall financial risk profile of the company.

The ratings continue to favourably factor in the company's leading position among tea plantation companies in India, and the premium quality of the company's tea, which fetch higher realisation than industry averages. Moreover, profits from overseas operations, although reduced in the current year, have supported operating profits on a consolidated basis.

However, the ratings also factor in the risks associated with tea for being an agricultural commodity, which is dependent on agro-climatic conditions, as well as the inherent cyclicality of the fixed-cost intensive tea industry that leads to variability in profitability and cash flows of bulk tea producers such as MRIL. In 9MFY2019, the improvement in tea prices was not commensurate with the increase in wage costs, thus adversely impacting the operating profitability of most of the organised bulk tea players in North India including MRIL. ICRA, nonetheless, notes that MRIL's considerable bought-leaf operations, along with the favourable age profile of its tea bushes, mitigates the risks associated with the fixed cost intensive nature of the bulk tea industry to an extent.

Outlook: Negative

The negative outlook underpins ICRA's expectation that input cost pressures would continue to impact the operating profitability and cashflows from operation, which along with elevated debt quantum on account of the exposure to group companies would keep coverage indicators depressed and liquidity stretched. The outlook could be revised to stable in case of a significant increase in prices, relative to costs, thus leading to healthy operating profitability and/or higher than expected reduction in exposure to group companies leading to lower debt. The quantum and timeliness of the reduction in debt would be a key rating sensitivity.

Key rating drivers

Credit strengths

Status of being one of the largest bulk tea producers domestically, notwithstanding reduction in scale; geographically diversified production base – MRIL produced around 89 mkg of tea in FY2018, accounting for almost 7% of the total domestic tea production. The consolidated production of around 118 mkg accounted for approximately 5% of the global production of black tea. The stand-alone production increased by around 5% during the year, and consolidated production, by around 3%. The globally diversified production base of the consolidated entity, with gardens in India, Uganda, Rwanda and Vietnam mitigates the risks arising from adverse agro-climatic conditions to some extent. MRIL has sold 21 gardens in India, which is expected to reduce almost ~32 mkg of total production, while the African stake sale will reduce almost 5 mkg of tea production, thus reducing the global production to around ~80 mkg, going forward. Notwithstanding the reduction, MRIL still remains one of the largest bulk tea producers from India.

Superior quality of tea produced by MRIL; high productivity and bought-leaf operations reduce the risks associated with the fixed-cost intensive nature of operations to some extent - The superior quality of tea produced in gardens both in the domestic as well as in the export markets, fetches a premium over industry averages. The average realisations of MRIL's produce fetches a premium to auction averages indicating the superior quality of teas produced. The favourable age profile of MRIL's tea bushes, with around 72% of the Indian bushes being below 50 years of age, results in the company recording a healthy tea estate yield. This directly impacts the cost structure due to the fixed-cost intensive nature of the industry. Though the operating cost has increased primarily owing to increase in wages, ICRA understands that the company has taken major cost-reduction initiatives to reduce the overall impact of the same. While some of the benefits of the same are expected in the current year itself, the full impact is expected only in FY2020. Nonetheless, increase in input costs would continue to keep the profitability under pressure. A large bought-leaf operation, which aids in better absorption of fixed overheads, reduces the overall fixed cost intensity of the bulk tea business.

Credit challenges

Exposure to Group companies increases the overall debt levels and results in pressure on debt coverage – Although MRIL used the proceeds from the sale of the first tranche of gardens (almost Rs 470 crore) to reduce debt, however, contrary to ICRA's expectation, total debt outstanding still remains high on account of increased exposure to group companies. ICRA notes that a substantial portion of garden sale proceeds, for the sale of the 2nd tranche of gardens, is expected in the short term with which the management plans to reduce debt, which would also support the liquidity of the company. Although



ICRA notes that the company has plans to reduce its debt over the short term, continued exposure to group companies, albeit reduced, would keep MRIL's borrowings elevated at least over the short term.

Significant deterioration in financial risk profile- Pressures on core operating profitability persists owing to depressed tea prices not adequately compensating for the increase in wage costs, notwithstanding the cost-reduction initiatives taken by the company. During 9MFY2019, there was considerable decline in operating profitability of the company. The performance of the overseas operations during CY2018 was also adversely impacted owing to subdued tea prices in the African market. Though non-operating income is likely to support the net profitability to an extent, input costs pressures is expected to keep the profitability of the company under pressure.

Risks associated with tea for being an agricultural commodity as well as the inherent cyclicality of the fixed-cost intensive tea industry - Tea production depends on agro-climatic conditions, which subject it to agro-climatic risks. Moreover, tea estate costs are primarily fixed with labour-related costs, which are independent of the volume produced, accounting for around 50% of the production cost. This leads to variability in profitability and cash flows of bulk tea producers such as MRIL.

Liquidity Position:

MRIL liquidity position remains stretched with deterioration in core operating profitability coupled with continued high exposure to group companies, which have been largely funded through external debt. As a result, repayment obligations remain substantial. With cashflows from operations under pressure, given the sharp increase in costs and muted increase in tea prices, MRIL would have to rely on reduction in group exposure to meet its repayment obligations. While ICRA notes that apart from the proceeds from the sale of the 2nd tranche of gardens there are other deleveraging and asset monetisation plans at the group level, which would also result in cash inflow into MRIL. The exact quantum and timeliness of the same would be critical in determining the liquidity position of the company.

About the company:

McLeod Russel India Limited (MRIL), the tea plantation company of the Kolkata-based B.M. Khaitan Group, was originally incorporated as Eveready Company India Private Ltd. on May 5, 1998. MRIL was formed after the demerger of the bulk-tea business from Eveready Industries India Ltd. (EIIL) with effect from April 1, 2004. MRIL has acquired several other companies like Williamson Tea Assam in FY2006, Doom Dooma Tea Company in FY2007 and Moran Tea in FY2008. These acquisitions helped MRIL increase the number of tea estates to 53 in India, with the total land under tea cultivation being 33,723 hectares (Ha). MRIL also acquired tea estates through its subsidiaries in Vietnam (three tea estates and seven factories), Uganda (six tea estates and five factories) and Rwanda (two tea estates and two factories) between CY2009 and CY2014, which took the total production to around 118 Mkg on a consolidated basis during FY2018. In the recent past, MRIL has sold 12 tea estate in Assam region and has signed MoU to sell more, both in Assam and in Dooars. Post conclusion of the sale, the company would have capacity to manufacture around 42 mkg of tea from own leaves. MRIL is primarily a producer of CTC tea, which accounts for around 96% of the total tea production.



In FY2018, on a standalone basis, the company reported a net profit of Rs. 67.3 crore on an operating income of Rs. 1597.8 crore, compared to a net profit of Rs. 30.5 crore on net sales of Rs. 1,388.7 crore in the previous year. On a consolidated basis, the entity reported a net profit of Rs. 219.2 crore in FY2018 on the back of an operating income of Rs. 2055.1 crore, against a net profit of Rs. 64.5 crore on net sales of Rs. 1772.1 crore in the previous year. In 9MFY2019, the company reported net profit of Rs 314 crore on an operating income of Rs 1134 crore on a standalone basis.
